1. Chair's Opening Address

The Chairman welcomed the attendees

1. Council Vacancy. There is one Council vacancy at present. This will be advertised on 9th December. One resident has already expressed their interest.

2. Apologies for Absence

Cllr Peter Foster is on leave of absence.

4. Minutes from Meeting Held 7th November 2024

The Draft Minutes for the meeting held on 7th November were proposed for acceptance by Cllr Oughton, seconded by Cllr. John Howard and passed unanimously.

5.Matters Arising – Outstanding Issues

a. Bellway situation update. Cllr. Howard reported that he has visited the Town Hall and had a discussion with the Planning Department and others. DBC has now reached a compromise with Bellway, and work has already started to complete the tasks which will satisfy both parties.

6. Ward Councillors Update

Ward Councillors Report 5th Dec 2024

Appeal Neasham Road Access

An appeal has been made to the Secretary of State against an enforcement notice issued by DBC.

The alleged breaches of planning control relate to the unauthorised removal of approx. 25 m of protected hedgerow, installation of unauthorised access into the land from Neasham Road with laying of hardcore materials to form an access road to Brickyard Farm Cottage.

The Secretary of State has appointed an Inspector to determine the appeal, and it will be dealt with by written representations and a site visit from the Inspector. All representations must be received by 27th Dec 2024 and must

quote the reference number APP/N1350/C/24/3349389. All the appeal documents can be viewed online on DBC planning applications website.

DBS checks for Councillors

This was discussed and agreed at the full DBC council meeting. We enquired as to whether the proposal also applied to Parish Councillors but it was determined by the Legal Advisor that as Parish Councils were separate bodies it would be up to them to make their own decisions on this matter.

Hopetown

Hopetown has recently received a highly prestigious Northeast Culture award for best museum or cultural venue. The venue has welcomed tens of thousands of visitors from all over the country and beyond since it opened earlier this year. It is certainly worth a visit particularly now whilst all the Christmas festivities are underway.

Bellway and Miller Sites

The footpaths and roads continue to remain in a state of disrepair whilst negotiations continue between Bellway and the Borough Council. DBC will not adopt the site and take any responsibility until Bellway have completed the required works to their exacting standard. Since last month's meeting there has been increased correspondence between residents, DBC, Bellway, Councillors and MP's. We have recently been assured by Bellway that they are working closely with DBC and so we await the outcome.

There has been no further correspondence relating to the Miller site which is in the same state of repair in terms of their footpaths.

7. Public Participation

A member of the public brought up the Miller & Bellway estates outstanding difficulties, and asked what the situation was?

DBC has made it clear that he Miller and Bellway estates must be brought up to standard before DBC will sign off.

If nothing is completed by January, then the option is that DBC will take over from Miller & Bellway estates and finish off the works and bill them for it.

A resident has already written to our MP.

Action: Lorraine Tostevin to communicate with DBC

Dog bins, on the Miller & Bellway estates.

This has already been reported to DBC.

8. Planning Application

In the absence of Cllr Willis, there was no Planning Application report. Two applications were received at the office, viz:-

- a. **Rockliffe Hall Hotel** have applied for permission to construct a new restaurant attached to the existing building. Also 6 parking places.
 - To date there have been no complaints or comments.
- b. Conversion of the **Hurworth Fisheries**, 12 Church Row, Hurworth. Application 24/00427/FUL.

This is for substantial alterations and extensions to the existing buildings. The existing fish shop will be converted into a deli, and a new building will be constructed behind the existing property, to create a bistro. All comments should be made to DBC before 24th December 2024. **Action**: The chairman and clerk

9. Tree Report

Cllr Debra Williamson gave the following report: -

TREE REPORT 5th DECEMBER 24

Goblins Wood - Sycamore Tree has now been felled.

Sewerage Issue Being Caused by Tree Routes

Peter and I had a meeting with a resident from Hurworth who had a concern that tree roots in the village are causing him a sewage problem in his garden. We advised we would make some enquiries, as to what can be achieved and whose responsibility it is. The resident was quite happy and said he would leave this is our hands.

Croft Riverbank

A letter from the Environment Agency was received in relation to a tree which was rotten and was to be felled on Croft Riverbank. A five-day notice was applied for, and permission was granted. This tree has now been felled.

Village Tree

A letter has been received from a resident that branches from a tree in a conservation area are now reaching her chimney pot and first floor bedroom window.

We are putting in a conversation tree application to DBC so the tree can be pruned.

Allotment Pathway

Members of the public have complained that if walking down the back of the allotments it is impassable due to overgrowth. We asked our arborist to take a look, and it has been agreed that the overgrowth needs to be cut back allowing access between the back of the houses and the allotments.

Ivy on Wall

There is an ongoing issue with Ivy growing on a protected wall, we need to get this removed to ensure no damage is caused to the wall. It has been agreed our arborist will remove the ivy.

Residential Root Damage

A resident has complained that tree routes are causing damage to her house. These trees are the responsibility on HPC. This is in the hands of our Insurance Company Zurich Insurance, and we await their response.

10. Open Spaces & Environment Report

Christmas Decorations

Other

We have given permission for an elderly resident to install a memorial bench on the grass area near the river at Croft Bridge. The request came via StreetScene.

We have the bills for the work that David Parker does for us in the village, such as looking after the war memorial, flowers, and grass/hedge cutting at Westfield Drive. We will ask David to continue with this work next year as it's important to keep the village looking well.

The village Litter Picker returned to work on Monday, 3rd December, after being on sick leave for 4 months. We thank John MacDonald who substituted during his absence.

12. Youth Activities Report

In her absence, Cllr Stamp submitted the following report: -

- 1. The Scout Hut and their 80k target Angie Graham, Lead Volunteer has given an update. The Scouts continue to fundraise to reach their target and had a night hike fundraising event on the 30th Nov and a Roseberry Topping in the dark event in Dec, with a spot of extreme ironing at the top. The gift from the Parish Council has not been spent or match funded yet, but drawings for the new hut have been received and are being reviewed. Once this is done, they will be applying for planning permission.
- 2. Xmas gathering FoHP/PTA worked with The Village Hall to put on a fantastic event for a switch on of the Christmas tree lights. They raised some much-needed funds for the Primary School.

- 3. The Christmas Fair was held on the 3rd December at the Primary School with all the village welcome, it was a great turnout and although the final total of funds raised is TBC it was a great event.
- 4. FoHP/PTA have also agreed to work with Peter Alan (Parish Clerk) on the re-invention of the Scarecrow festival details TBC
- 5. Hurworth School Rewards Evening is on the 17th December from 5.30pm. Peter Allan intends to attend as a representative of HPC.

13. Crime & Security Report

Cllr Oughton reported as follows: -

14. Rights of Way & Parish Walks

Cllr Peter Williamson reported: -

Rights of way report update 4/12/24

It's that time of year again and people need to take extra care while out walking, making sure they are using the correct type of footwear for the conditions under foot (mud/water).

Footpath 1 - Coach Lane to Emerson Road

Due to the DBC rights of way officer being sick, there is no update on what repairs will be done. There have been more reports of vans crossing the grass where the broken bollard is.

Footpath 11/Teesdale Way

There is no update on either of the above due to the DBC Rights of Way Officer is off sick. We are not escalating this at present, as his return to work is due shortly.

If escalated, the person responsible would have to start from the beginning and could only delay things further. The ROW Officer is very efficient and very quick to respond normally.

15. Allotments Report

Cllr Crisp reported that activities on the allotments have now virtually ceased due to winter conditions.

The Annual General Meeting will be held on Wednesday, 11th December at Hurworth Grange, starting at 6:30pm.

16. Roads & Pathways Report

Cllr Forster reported that there was nothing to report.

17. Correspondence & Matters of Interest

a. The work on the roof of the Hurworth Grange garage block has been delayed. This time slippage has allowed time for a grant to be applied for; the application has been submitted.

- b. **Hallam Land proposal and consultancy**. Cllr Tostevin stated that she raised this matter at the DBC Planning Meeting in November and was reassured that any application for building houses on this site, or within Hurworth Parish during the next two and a half years will be refused. The DBC is clear that Hurworth has already undertaken its allocation.
- c. **Hurworth Parish Council Contingency Plan**. The Chairman referred to the presentation made at the November meeting relating to establishing a Plan, with funding, so that the Parish is prepared for an imminent crisis. Cllr Peter Foster has been the Contingency Officer, and several people had volunteered to be on the Contingency team. Cllr Foster is unable to continue in this roll, and it was agreed that Cllr John Howard would take over the leadership and form a group to address this need.

18. Projects 2024-2025

Cllr Forster reported that the wood carving project is now complete. The Clerk has completed the End of Project report and submitted all the invoices. The balance of the grant should be received within 14 days.

Cllr Forster stated that the group would like to stay united and to undertake another project. A proposal will be submitted at the next meeting.

19. Accounts for Payment
