1. Chair's Opening Address

The Chairman welcomed the Councillors and members of the public.

4. Minutes from the Meeting Held 11th May 2023

5. Update on Actions

- **a.** 20 mph speed limit on Hurworth Road. Cllr Tostevin stated that there was no update at this time.
- **b.** The Clerk reported that we not received a delivery date for the Strait Lane monitor yet. Also, the DBC Highway Dept, who are selecting the location and erecting the post, have not yet acted. Cllr Tostevin agreed to follow this up.

6. Ward Councillor's Update

Ward Cllr Tostevin and Ward Cllr Walters reported: -

Following the Local Darlington Borough Council elections, we now have a new leader of the Council which is Councillor Steve Harker. In total there are 50 Councillors and as no political party gained overall control the Labour Councillors and Lib Dem Councillors will now be working together to form a majority to lead the Council.

We also have a newly appointed Mayor of Darlington which is Councillor Jan Cossins. This is a one-year term of office.

There are some planned roadworks for Hurworth commencing on the 5th June. This includes repairs to Strait Lane and works to footpaths and kerbing on the Grange Estate which will start on Avon Road, Fox Close and Hunters Close.

The Grange estate work is expected to last for 7 weeks.

The Ward Surgeries will be commencing soon and will be on the first Tuesday of the month at 5.30 to 6.30 by appointment at a location to be confirmed.

7. Public Participation

- a. A resident asked for details of how Hurworth Grange is managed. The Chairman invite the Clerk to provide a brief summary. Hurworth Grange is owned by Hurworth Parish Council, and is leased to the charity Hurworth Community Association, on an 'all repairing' lease. This lease has been renewed regularly for 52 years. The Grange Bar is a tenant of the Community Centre and pays a rent and all profits are given to the charity. The Coffee Pot is an integral part of the Community Centre. The allotments are controlled by the Parish Council, and the playground is the responsibility of Darlington Borough Council.
- b. A resident expressed concerns about the safety of the smaller Grange entrance, and suggested that a gate be installed. The Clerk responded that this entrance must be disabled- friendly, as it is part of the circular route around the estate, which is designed to accommodate wheelchairs and children's pushchairs and prams.
- c. Several residents expressed their dismay that the number 12 bus will cease to operate in mid July. The Chairman sympathised with the comments, but said that as it has just been announced, it was a little premature to discuss the subject. Cllr Tostevin informed the meeting that there are some Section 106 funds, which were earmarked for an evening bus service, that possibly could be used as a short-term solution.
- d. A resident said that the congestion on the Grange internal road was causing problems and that the road signs needed to be better positioned.

Councillor Reports

8. Planning Applications – Cllr Willis Cllr Willis reported:

9. Roads and Pathways - Cllr Willis

Cllr Willis Footpaths/roads reported:

Residents are complaining about the overall poor condition of the Roundhill Road pavement from Mowbray Drive to Westfield Drive – ongoing

Grass cutting of Manor Fields and The Green required – frequency? It is understood that this is every three weeks during the summer period.

Numerous footpaths are becoming overgrown with weeds/nettles etc

10. Trees – Cllr Foster

In the absence of Cllr Foster there was no report. The Clerk advised the council that he made arrangements to purchase the oak tree, as agreed at the last meeting.

12. Open Spaces and the Environment - Cllr Andrew Leigh

a. There was no report, but the Chairman enquired about the broken bench on the pavement heading to Neasham. The Clerk reported that the bench had proved to be not worth repairing and advised that we should purchase a replacement. The council agreed to purchase one bench made from recycled produce. The benches of this type have proved acceptable and need little or no maintenance.

b. A resident expressed is concern about an overgrown tree near Friars Pardon. Action the Clerk will identify this tree and have it inspected, as the ownership is unknown at this point. (It is probably one of the trees in Goblins Wood).

13. Highways and Traffic

Cllr Dorothy Oughton reported:

a. Traffic Report

The full details of traffic volumes and speed are shown separately on the HPC web site.

The average speed on Roundhill Road, Hurworth has reduced again and is now 22mph.

The other monitor locations are also following the trend with the average speed throughout is reducing. All locations are lower than 30mph average.

There are still some instances of high-speed driving, with speeds of over 70mph being recorded, but these could be emergency cases.

b. No speed watch sessions were conducted in May. Some training sessions are required before the new team start active recordings.

15. Allotments – Cllr Crisp

Cllr Crisp reported:

The strait Lane allotments have one person on the Waiting List.

The supplier which the council has been using for purchase fertiliser can no longer provide the quantities we require, and price we have been paying.

Cllr Crisp is contacting alternative suppliers and hopes to resolve this problem within a couple of weeks.

Cllr Crisp took this opportunity to inform the meeting that the bus stop library has been trashed again last Friday evening. It appears coincidental that this behaviour occurs near the youth club, on youth club nights. The incident has been reported to our new PCSO.

16. Matters of Interest

- **a. Beech Tree Carving Project** Cllr Forster reported that there has been no progress, but the speaker for the group will make a presentation at the July PC Meeting.
- **b.** Church graveyard The Clerk reported that there have been many complaints about the state of the graveyard at All Saints Church. He explained that the graveyard is in two sections, with DBC being responsible for the westside of the church, and the east side is the responsibility of the Hurworth and Neasham Burial Trust.
 - The grass has now been cut and a 'clean-up' session has been planned for Saturday, 10th June starting at 10:00am, Volunteers are most welcome, bring your own tools. A skip has been booked.
- **c.** Councillors' declaration of election expenses. Although there was no election, each councillor must complete and sign a form for DBC stating that they do not have a claim for any election expenses. The councillors present signed their forma at the end of the meeting. Also, all Declarations of Interest statements have now been completed.
- d. Bellway. Cllr Willis has had a response from a senior manager from Bellway, who is putting forward a ten -point plan. A meeting will be arranged with Bellway and Cllr Willis and the Clerk.
