1. Chair's Opening Address

The Chairman welcomed the attendees

1. Council Vacancy. Three applications have been received. The Chair, the clerk and one other Councillor will interview the candidates and make a selection.

2. Apologies for Absence

Cllr Peter Foster is on leave of absence.

4. Minutes from Meeting Held on 5th December 2024

Cllr Tostevin requested a modification to the draft Minutes, item 5, relating to the Bellway estate. The sentence 'The handover to DBC can be expected in January 2025'. was removed.

The Draft Minutes for the meeting held on 5th December were modified accordingly, and accepted, proposed by Cllr Oughton, seconded by Cllr. Crisp and passed unanimously.

5.Matters Arising – Outstanding Issues

1. Hurworth Grange replacement of the garage roof. Work has not yet started. A grant application has been submitted, on behalf of Hurworth Grange CIO, and a decision is expected by mid-January. The work is expected to start before the end of January.

6. Ward Councillors Update

Ward Councillors' Report 2nd January 2025

- 1. Cllr Walters said he had nothing to report
- 2. Cllr Tostevin drew the Councils attention to two consultations: the Medium Term Financial Plan (MTFP) and Pavement cafes, both can be viewed on DBC website. Residents are able to post their comments.

7. Public Participation

- 1. A resident raised the question, again, about Footpath 11. The footpath is virtually unusable at present due to flooding. What is being done to get the path relocated to its original routing? The chair explained that this is with the DBC Planning Team, and the matter can only be settled with the landowner. The landowner has made it clear that he does not wish the path to go through his field using the previous route. At present, there is nothing this council can do to assist the resident.
- 2. A same resident asked the Council to improve the surface of the Right of Way behind the Grange possibly using the Precept. Cllr Peter Williamson stated that making it higher through resurfacing, could cause flooding problems for householders on the Grange housing estate. Furthermore, the land owner had already assisted with the style, and is not prepared to do further work. The Chair added that this resident appears to be the only person concerned, and that many Hurworth residents would not want tarmac surfaces on country walk paths.
- 3. A resident raised the problems still outstanding on the Bellway estate. Cllr Howard read out a message from DBC that stated that they will not register the estate until a number of outstanding issues are rectified and the residents are content. Cllr Tostevin stated that DBC will not take over the responsibility and potential liability of

adopting the Bellway or Miller estates, until they are satisfied that all the outstanding work meets the agreed building standards. Section 38 had been discussed, but will not be applied at this time.

Finally, Cllr Tostevin agreed to go back to DBC, and enquire as to the current position on both estates. **Action Cllr Tostevin**

8. Planning Application
