

Minutes of the Hurworth Parish Council Meeting held on Thursday 2nd November 2023, starting at 7:00pm at Hurworth Grange

1. Chair's Opening Address

The Chairman welcomed the Councillors and members of the public.

- a. He reminded the Councillors that the Finance Meeting will follow the end of the public meeting.
- b. Remembrance Day is on 12th November and two wreaths have been ordered, for the Council to lay after the service at All Saints Church.

4. Minutes from the Meeting Held 5th October 2023

The Minutes were accepted by the Council, proposed by Cllr Oughton and Seconded by Cllr Forster.

5. Matters Arising

a. Twenty mph limit on Hurworth Road consultation

Cllr Tostevin reported – The Scheme will go ahead subject to Cabinet approval, however there are some outstanding suggestions from the resident responses regarding the parking restrictions outside the school and a pathway between the rear of Friars Pardon and the rear of the Grange which require further consideration.

b. Bellway Estate

Cllr Willis was not available to attend this meeting, but has informed the Chairman that he has still been unable to arrange a meeting with the Bellway management. Action remains.

c. Spar shop

Cllr Walters informed the meeting that the Spar shop has arranged for the deliveries to be in the twilight period, between 6; 00am and 6:30am. He has cleared this arrangement with DBC. . Matter closed

d. Minutes recording query

Errata: - With reference to the HPC Meeting held on 7th September 2023, item 20, Any Other Business, a resident reported a 'motorcycle' driving on the Hurworth Grange field. This is hereby corrected to an 'e scooter'. Matter closed.

6. Ward Councillor's Update

The Ward Councillors gave the following report: -

- 1. The former Darlington railway museum site has received a multimillion pound investment to celebrate 100 years of the Darlington Stockton Railway (2025) and will re- open in 2024. The new name for this Centre will be Hopetown. It is hoped that the Centre will receive worldwide acclaim as a new visitor attraction.
- 2. There have been several incidents of fly tipping in and around Darlington. One person has been fined £40, with £130 costs. Some residents feel this fine is too low, but the Head of the Communities at DBC feels that it still sends out a stern message. It has been suggested that the level of fine should be increased however; this is a matter for the courts to determine. There have been further incidents of fly tipping in the Burma Road area.
- 3. There has been no further progress made in relation to the new road opening onto Neasham Road close to Skipbridge. To date no planning application has been submitted and Highways who have made certain stipulations have agreed to take further action if their proposed actions are not heeded by the owner.

4. There will be a delay to the building of the new 141 Houses on the estate opposite the stadium due to the number of credits available in relation to nutrient neutrality. There are credits for 51 houses but a further ninety are still outstanding.

7. Public Participation

A resident expressed is concern about the condition of the Rights of Way around the Middlesbrough training ground. He stated that the drainage is poor and there is an amount of standing water. Cllr Forster volunteered to make an inspection and report back. Action Cllr Forster.

The same resident raised the ongoing issue regarding the alteration to the route of the right of way within the Rockliffe Hall area. The heavy rain and oncoming winter weather are making the new route almost impossible to use. The ward councillors agreed to look into the progress of this issue, which is between DBC and the land owner. **Action Cllr Walters/Tostevin**

8. Planning Applications – Cllr Willis

Cllr Willis submitted his report, and Chairman read it out to the meeting, viz: -

Planning

There have been 2 planning applications made since the June report

1) 8 Hawkswood Hurworth Place

Erection of single storey rear extension and outbuildings

2) Rose Villa Timmys Lane

Demolition of existing dwellings, barn, stables

Erection of one wheelchair accessible detached dwelling with detached garden studio/store and parking provision

I have had no success regarding progress contacting Bellway re outstanding landscaping issues

Unable to establish contact with Dave Coates – DBC planning department – regarding Bellway original planning application or the wall erected at 12 Manor Road

9. Roads and Pathways Report

Cllr Forster submitted the following report: -

Footpaths/roads

Arrangements have been made for the grit bins to be filled during November. Cost £741.

There have been no complaints raised during October, and the Village Green potholes will be discussed later in the agenda.

b. Village Green pot holes

The Chairman reported that we have received three quotations for this project. The prices are substantially different, and the Chairman wishes to speak to two of the contractors to ensure that they are both working to the same specification. A decision will be made after the clarification has been made. **Action Cllr Leigh.**

10. Trees – Cllr Foster

Cllr Foster reported that despite all of the heavy rain, the trees for which we have a responsibility are all in good condition.

Cllr Foster has made an inspection, as he had concern that the rain may disturb or loosen the roots, but fortunately all is well.

a. The tree on Coach Lane

The tree was inspected, and StreetScene asked to cut off the broken branch and trim the tree canopy. The canopy has been trimmed, but the broken branch remains.

- b. **The tree on Roundhill Road** which is leaning badly, could potentially become more dangerous, and an email has been sent to Phil Haynes, who is head arborist at DBC.
- c. There are seventeen trees in a plantation near the Neasham Darlington road which have contracted Asd dieback disease, and need treatment. The owner has been contacted and has agreed to attend to them.

11. Youth and Playground -

Hurworth House School has requested a meeting to discuss ways in which their pupils could participate in community events.

Cllr Oughton, Cllr Forster and Cllr Crisp have offered to attend a meeting, which the Clerk will now arrange. Action Clerk

A children's get-together is being arranged to switch on the Christmas tree lights.

Arrangements have been made with DBC to provide the electricity from the nearby lamppost.

HPC has signed an agreement with DBC to provide the power at a cost of £50.

12. Open Spaces –

Cllr Charlotte Marie Kay was not present at the meeting, but had transmitted suggestions to the Chairman

Cllr Kay drew attention to the pathway which runs from the Glebe to Hurworth Place, and suggests that the condition of this pathways in poor condition and requires more substance. Cllr Tostevin had already reported that suggestions relating to this path were being considered as part of the 20mph changes at Hurworth School as it is recognised that it is used as a School Route.

Cllr Marie Kay also recommended that there should be a substantial pathway leading to the Tawny Owl inn.

Action Cllr Williamson.

At the October meeting, Cllr Foster stated that a heavy chain has been put around a style to prevent use. It was agreed that Cllr Russell will be asked to cut and remove this and make the style save. Cllr Williamson has investigated this problem further, and will be arranging for the chair to be removed, and at the same time the gate to be made safe.

Cllr Foster expressed his concern that there are two signs at the Burma Road, displaying 'Cross Here' and pointing to the A66 as the pathway to cross the main road. His felt this was potentially extremely dangerous, as children may follow the signs and try to cross the main road. After a discussion, the Chairman closed the conversation saying that HPC would take no action, as this is, indeed, the designated route.

16. Allotment Report

Cllr Crisp did not attend the meeting.

- d. **Correspondence** Chair. Following the October meeting, we received a letter from a resident, containing several questions, A reply has been sent covering all the questions.

- e. **New Hurworth Grange lease** The Chairman reported that we are waiting for the lease to be legally reviewed. This is expected to be finalised in November.
- f. Council Notice Boards The Parish Clerk advised the Council that the two council notice boards are now in very poor condition. One has been temporary replaced with a notice board which had been used in earlier years. The other is in distress.

 Also, now that there over 100 residents of Hurworth Parish living on the Elder Brook Park estate, it is the Council's duty to provide council information, and a notice board is required.

There is a large range of notice boards, and the Council will select an appropriate model, once the pricing has been obtained. **Action Clerk to follow up.**

18. Projects 2023-24

a. Beech tree carving project – Cllr Forster reported the progress on the Tree Carving Project.

Tree Carving Project - 24.10.2023

£2000.00 arts funding is being applied for through Durham via The Hurworth Grange

Discussed tools and usage, and materials needed for carving sessions.

Skills building sessions for carving are being arranged, and contact to be made with primary school, scouts and linden court for seasons to be held, so involving the whole community and all ages

Taster sessions to be on the mornings or 22nd and 29th November at the grange, information to be posted on Hurworth Live.

Arts funding application also being looked into.

As the Tree stump is holding water in the centre, looking into making a channel so this can be drained away.

b. Emerson Road footpath – This is Cllr Oughton's proposed project.

Three quotations have been received.

The Council wish to go ahead with the project, and after discussion selected the quotation from Darlington Borough Council. One of the other quotations was attractive but the Council felt more comfortable working with DBC, who also cut the grass in the immediate area.

The motion to proceed with the DBC quotation of £4027 was tabled by Cllr Leigh and Seconded by Cllr Forster, and the vote was unanimous in favour.
