232. Chairman's Address

The Chair, Cllr Winnett, opened the meeting.

233. Minutes of the Meeting held on 5th March 2020 were accepted by the Chairman and endorsed by Cllr Dorothy Oughton.

234. Matters Arising

The Chairman reported on the following items:-

- a. **Broadband** – Our letter of complaint has had recognition from our MP and Tees Valley Combined Authority. The issue of roll-out is under review but no positive news as yet.
- b. **Defibrillators** – We look to re-site the third defibrillator at the Mustard Tree in the near future. A better location where the unit can be well placed, if necessary, to save the elderly clients of the Mustard Tree when it is back in operation. Agreement with the church is expected by 10th April.

236. Playground Planning Working Party Report

Cllr Lynn Wylie reported as follows:-

237. Hurworth Youth Project

No decision should be made on this application until the current Coronavirus situation has been resolved & any relevant public planning meetings are able to go ahead. At the 2019 public consultation on the Local Plan held at The Grange, Hurworth, the residents of Hurworth were promised by the architect of the Local Plan that no more developments of this size would be given planning permission in Hurworth . This statement was given to urge residents to agree to the Local Plan & aid its progress.

In response to several resident's queries and for general interest, the Council, through our Ward Councillor Tostevin, asked the Head of Planning at DBC to make a definitive statement, which could help us to clarify the Outline Planning Application made to construct 175 house on Roundhill Road.

We received this statement from the Head of Planning, Viz:-

The site in question is located outside of the established housing development boundaries for the Borough of Darlington and is classified as Countryside. As the Council can demonstrate a healthy 5 year supply of housing permissions, there is no need to consider sites such as this one as a development site at this time. Furthermore the Council is moving forward with a new Local Plan which it hopes to have in place late this year. The plan does not include this site as an identified site for development for the foreseeable future .

We hope that this statement will satisfy any queries on this subject.

240. Open Spaces & EPICH Report

Cllr Lynn Wylie reported as follows:-

a. Open Spaces Report –April 2020

The Heritage Orchard has been pruned under the supervision of Cllr Foster, and is looking in good shape.

The contract for the maintenance of the Grange pathway has been postponed, and the Grange staff will monitor it.

b. EPICH Report –April 2020

A meeting was held on 11th March, salient points recorded included:-

Extracts from the EPICH Meeting:-

New / Ongoing Projects - Pat Simpson

~ **Jean's Garden** - £2000 available in HPC budget for landscaping. There was discussion in the meeting regarding this and the general feeling is that EPICH doesn't have the knowledge or expertise or man/woman power to undertake this. It was suggested that members might wish to approach various garden centres and ask for free advice.

It was also suggested that a meeting with the HPC might be useful to understand what they are hoping to do with the area. Peter Allan will ask for definite ideas from the council.

~ **Lychgate Tidy Up** - on Tuesday 7th April at 1.30

Wilma Cambell will leaflet the residents to see if there are any volunteer helpers.

Cllr Peter Foster would like to replace the tree smothered in ivy on the grass "island" at the front of Lychgate with a non fruiting pear tree.

~ **Bulbs "in the green"** - Judith Redfern.

This has been temporarily put on hold because of the potential referendum on the green spaces and second play area but the meeting decided to go ahead with the plan to plant along the footpath past the primary school between Westfield Dr and Roundhill Rd. This area is owned and maintained by DBC, Pat Simpson will contact Street Scene to see if there are any problems/objections.

~ **Bee Report** - Tony Needham

Unfortunately we have lost one hive. This is in line with general expected winter losses.

The Bee Group think this is down to possibly the hive didn't have enough numbers to maintain themselves or the Queen could have failed during the winter meaning that no replacement eggs/bees were being laid/born.

However the other hives and one in particular appear strong and the bees are often to be seen out on sunny, milder days. The Bee Group are considering a spring treatment for varroa and Pat will research the available information.

241. Allotment Report

Cllr Crisp reported that the one vacant allotment has now been taken.

The allotments are open at both Hurworth Grange and Strait Lane, and plot holders are encouraged to take advantage of the lock-down, to get exercise at the allotments.

All allotment holders. Registered Helpers and visitors must adhere to the Government rules and keep well apart, and there should be no more than two people on any one site.

242. Pathways and Rights of Way

A number of pathway repairs are still awaiting attention, and they will be addressed as soon as resources can be assigned.

The designated pathways are all open, and now that the rain has stopped they have become accessible.

Residents are encouraged to walk the pathways, and report any blockages or problems that they encounter.

Remember no more than two people together, no groups, and keep your distance, please.

243. Playground and Youth Affairs

The schools and all youth club facilities are closed for the foreseeable future.

244. Highways and Traffic Report

1. Cllr Dorothy Oughton reported that a number of tasks are still outstanding and will be addressed as soon as resources are available.

a. Dog Bins

DBC has informed the Council that dog bins will not be emptied during the crisis, due to lack of resources.

This means that dog owners must pick up, and take home their dog bags.

Cllrs Graham and Cllr Lynn Wylie have locked down all the bins and placed notices on them and at other locations, requesting dog walkers to heed the council's request to be responsible and 'pick up and take home'.

b. Speed Watch

Due to the lock down, no sessions were held.

2. **Traffic**

The volume of traffic since the lock down has dropped dramatically. Also is noted that, with a few exceptions, the speed levels have also dropped. There is a general lack of urgency.

245. Matters of Interest

a. Parish Logo.

b. Risk Assessment

The updated Annual Risk Assessment has been updated and circulated to all Councillors. This document forms part of the Governance declaration, and is a mandatory document. All Councillors are required to accept the document and have been requested to contact the Clerk if they have any queries or are not prepared to accept the wording.

246. Police Report

Cllr Oughton submitted the following Police Report:-

HURWORTH CRIME FIGURES MARCH 2020.

HIGHWAYS:

02/03 – Parking issue reported again on Hawkswood. Officer attended but no obstruction at the time. Officer has sent a referral to the Civic Enforcement team for them to assess the situation.

SUSPICIOUS ACTIVITY:

09/03 – A resident on Lychgate has reported a male going door to door selling fish products, but did not show any I.D. Description given as white male approximately early 30's with mousey brown hair. Please be aware and ring the police if you are approached.

BURGLARY:

16/03 – A resident on Friars Pardon reported that overnight, someone has attempted to gain entry into the garage by removing tiles off the roof. This was an unsuccessful attempt and was recorded as attempt burglary. There have been no lines of enquiry as there were no witnesses and no CCTV. This crime has been closed, but can be reopened if any evidence comes to light.

VEHICLE THEFT:

24/03 - Report of a vehicle being taken from Pilmore Mews. Officers have attended and confirmed a crime of vehicle theft. This is an ongoing investigation.
