Minutes of the Hurworth Parish Council meeting Held on Thursday 2nd October 2025 starting at 7.00pm

1. Chair's Opening Address:

The Chairman welcomed the attendees, and started the meeting by introducing Peter Williamson.

Mr Williamson addressed the Council saying that he would like to join the Council, and would be prepared to take on the role of Tree Management, which is vacant at this time.

The Chairman then invited Mr Wiliamson to join the Council, who then signed the Acceptance Register, which was endorsed by the Parish Clerk.

4. Minutes from Meeting Held on 4th September 2025:

The Draft Minutes for the meeting held on 4th September, were accepted, proposed by Cllr Oughton seconded by Cllr .Allan, and passed unanimously.

The Draft Minutes for the Special Meeting held on 25th September, were accepted, subject to one change, requested by Cllr Forster. Proposed by Cllr Howard, Seconded by Cllr Oughton.

5. Matters Arising:

Rockliffe Cricket Club.

The Chair reported that we have not received a decision yet, from DBC regarding the decision of whether the £7,000 funding committed by HPC is going to come from the section 106 money. Action still open.

6. Ward Councillors Update:

Ward Councillors Report October 2025

Bellway and Miller Sites

Work to the footpaths and roads continues on the Miller site and most residents seem happy with the progress. There are still a number of points to resolve before there is agreement from all residents to proceed with the works on the Bellway site. The ward Councillors and Highways team are currently in the process of speaking to residents. The possibility of adopting just the part of the Bellway site which has already been completed is also being considered by DBC and Bellway.

Stockton and Darlington Railway

The 200 year celebrations to commemorate the Stockton and Darlington Railway took place last weekend. Thousands of people across the region gathered to see the Replica of Locomotion One cross the Skerne Bridge which is the oldest working bridge in the world. It was a momentous occasion. All the associated celebrations were a great success.

Resident Parking Zones

Darlington Borough Council is reviewing its policy on Resident Parking Zones. The review looks at both existing Zones and suggestions from residents on any new Zones which they believe should be introduced. This is a town wide survey and includes Hurworth. The short survey can be found on DBC website or a paper copy is available from the Town Hall in Darlington. Surveys should be returned by 13th October 2025.

Dolphin Centre

Upgrades to the Swimming Pool in the Dolphin Centre took place last year and the pool is much improved and well utilised. Proposals are being submitted at the full Council Meeting tonight to approve release of finance to create indoor golf, interactive darts and shuffle board areas. There is also a proposal for a new studio of spinning and exercise equipment. These new facilities will be available to existing and new users of the Dolphin Centre and should help to further increase its attraction.

Flu Injections

Residents over the age of 65 are being encouraged to take up the offer of a flu injection this winter. The injections are available in surgeries, pharmacies and other locations across Darlington from October. There is also a programme available for Children's Flu prevention.

Local Plan

The local plan review is underway and the first draft will be considered in November. There is currently a call for sites for local green spaces. This is open to submission from local communities and includes recognition of green spaces which are of significant value to the community.

To be designated these spaces should be:-

Of significant importance, reasonably close in proximity to the community applying, demonstrably special to the community in terms of beauty, historical significance, character. Playing fields are also included.

This may be of interest and warrant an application to include some of the green spaces in Hurworth. The sites if approved will be included in the revised Local Plan.

7. Public Participation:

- 1. A resident requested that the trees in Church row flat compound require trimming: Action Cllr Howard and Clerk
- 2. Sue Dell, who is the Flood Warden at Hurworth Place address the Council. She is concerned about the coming winter, and the danger of flooding, both from the drainage behind the houses at Tees View, and the river rising. The environment Agency are installing new 'measuring units' at Croft bridge, but there is a delay. Sue says that the sandbags, held in the toilet block, are inspected every month, and there is a team of Flood wardens, who meet regularly.
 - The Chair was please to inform the meeting that the new parish Plan includes the resurrection of the Hurworth Contingency Team, and that Cllr Howard is leading this project. Cllr Howard said that he would get together with Sue Dell and her team, and that that will work together, to try to satisfy the concerns which have been expressed. **Action Cllr Howard**.
- 3. A resident was concerned about a current planning application for Meadowbank Close and whether it would increase the risk of flooding.

8. Hurworth Parish Plan 2025-30

The Chair reported on the current status of the new Parish Plan,

The Special Meeting advanced the Parish Plan considerably, and the Clerk advised the meeting of the current status;_

The revised draft Plan has been completed, and needs to be validated,

Four copies were printed out,

- One for the Chairman to check that all the objectives ad commitments are accurate
- One for Cllr Tostevin, to read and improve upon the flow of the document, and ensure continuity.
- One for Cllr Willis, so he can ensure that the Projects which will materialise from the Plan, are correctly defined.
- One for Cllr Wylie, who has undertaken to convert the word-based version into a 'publish ready format, either using AI or Publisher.

In order to complete the Plan, there are still seven topics, which the Council need to make decision, and decide which will be included in the final Plan.

It is hoped that these tasks will be completed by 31st October.

A Public Meeting will then be arranged, so that the residents formally 'accept' the 5-year Plan

25/00984/TF - Cross Bank Hill, 1 Blind Lane, Hurworth, DL2 2JB

Description

Works to 1 no. Sycamore protected under Tree Preservation Order 2002 (No.1) T1 - thin out lower limbs to remove over hanging/crossing branches and dead wood.

25/01004/FUL - Land at Mole End, Neasham Road, Hurworth, DL2 2AZ

Description

Erection of 1 no. three bed self-build dwelling with a detached garage/store, hard standing, landscaping and provision of a new vehicular access with entrance gates and wall.

10. Tree Report -

The Clerk reported that three dead elm trees have been felled within the Grange grounds, and the trees overhanging the pathway have been trimmed to allow light from the street lamps.

Two trees on the Village Green have been trimmed to lower the canopy, for vehicles to pass without touching them.

The oak tree planted for Cllr Peter Foster has died, and will be replaced.

Cllr Williamson reported as follows:-

Linden Court

At the recent MP's local surgery residents from Linden Drive, reported that they were having issues with several trees.

MP reported this to DBC, who in turn sent their arborist who reported the following:

- Large branches hitting houses on the opposite side of the road.
- 2 Silver Birch trees at the side on No. 5 property hitting the side wall and roof of the property.
- At the rear of the row of properties, where there is a rear access, 3 trees have Ash Dieback and need removing.
- Numerous self-seeding trees have very bad form and need removing.
- Ivy needs severing on all trees.
- Large Sycamore at rear of No. 5 needs reducing away from the rear garden.

This report was forwarded by DBC to HPC to be dealt with.

A site visit was conducted on Tuesday 23th of September 2025 by Guy Foster (Arborist), Peter Allan (Parish Clerk) and in attendance Peter Williamson, to confirm the findings by DBC Arborist.

Further investigations are being carried out to determine, referencing the Land Registry, who owns the land in question, before any work can commence. **Action Clerk and Cllr Williamson.**

15. Crime & Security Report - Cllr Dorothy Oughton

16. Rights of Way & Parish Walks – Cllr Janine Forster

Paths 6 & 7 Walked 28 September 2025.

Route description

Follow Timmys lane (path 6), This path was diverted last year. The path now takes the track down to Cree beck, instead of across the field. Then right along the beck edge of the field, which is kept cut and easy to walk. This then joins the original path where a new opening has been made and a new fence put up making the walk to the concrete bridge much easier. (pictures 1-4)

Turn left after the bridge along the edge for the beck, then across the fields to Neasham road. The path is nonexistent at this time of year as all the crop fields are ploughed, which makes the walk difficult in the soil. (picture 5) The route crosses Neasham road, both stiles onto the road and off, have little space from the busy traffic and is a dangerous climb over.

Now on path 7 turn left behind Spring Cottage over 2 stiles and pass a small pond, these Stiles are in reasonable order.

The way continues towards Neasham Springs farm over the ditch bridge and stile, continuing on to the track road and through the farm, the path is easy to follow coming out at Low Maidendale farm.

From this point follow the track which passes the plantation wood, coming out onto Burma Road.













<u>Action</u> - As advised in previous reports on this route, the stiles over Neasham road need to be made safer with easier

And quicker access, possible kissing gates of similar.

17. Roads & Pathways Report and Hurworth Contingency Plan - Cllr John Howard

No report this month

Cllr Howard requests that we purchase some additional grit bins. These are to be deployed in Hurworth Parish, excluding the new estates at Elder Brook Park and Hurworth Meadows. A decision of these two estates will be made later. **Action Cllr Howard: number of new bins and location of them.**

18. Correspondence & Matters of Interest

- a. The Mustard Tree café are intending to install an electric automatic door, to assist the older generation of customers and t=the disabled. The total cost is £12,000, and they have already raised £8,000. They are enquiring whether the Parish Council to assist. After a short discussion, the Chair asked for a proposal. Cllr Allan proposed that the Council award them £4,000, Seconded by Cllr Oughton. The vote taken was 7 in favour, one against. **Action**; **Clerk** to arrange payment of this section 137 award.
- b. HMS Hurworth have written to the Council asking if we would like an officer and 25 of the crew to attend the Remembrance Day event on 9th November. The Clerk has made some provisional arrangements, which is for the crew to attend the service at All saints Church, the Captain to read the memorial speech, and then the church will be laying on a 'faith lunch' in the Village Hall. The Council are all invited and the Chairman and Cllr TostevIn will be laying wreaths. This is to be confirmed by HMS Hurworth.

- c. Christmas carols. The Village Hall will be organising the switching on of the Christmas tree lights on 30th November. There will be a lantern walk from the church to the Christmas tree. The PTA will not be participating this year, and the Hurworth Scouts may be asked if they would like to participate.
- d. Salt bins. The council has agreed to purchase some additional salt bins. Action: Cllr Howard is overseeing this project.

2. Elderbook Park and Hurworth Meadows Report

Cllr Mann submitted the following report:-

HPC Monthly report for Elder Brook Park and Hurworth Meadows Estates October '25.

- The estates eagerly await the arrival of the public waste bin from the opposite side of Neasham road. Confirmed to be in situ by Friday 3 October
- Amount of builders' litter has reduced after a series of complaints by residents Much still remains in the hedgerows, in the reserve and along the paths near to the construction site. Thought being given to getting a group together to litter pick on a regular basis.

- Escalation of nighttime prowlers on the estate and the Police have been called regularly. Need to ensure these are included in the Hurworth Crime figures.
- The management of green spaces by Trust Green will only commence once everyone has paid the yearly maintenance fee. The site is being handed over in sections so until that is complete little maintenance will be undertaken. Up until that time the estate is reliant on the developer's landscape contractors to undertake work. I will be reminding the developer of their obligations until they leave the site in 2027.
- Attended a meeting with the Ward Councillor Lorraine Tostevin and Parish Clerk. This was to understand more about the local area around the estates. It was very useful.

3. Hurworth Grange

The Stable Block roof has now been completed, featuring a small overhang finished with the spare tiles that were left over.
