

Minutes of the Hurworth Parish Council Meeting held on Thursday 7th March 2024 starting at 7:00pm at Hurworth Grange

1. Chair's Opening Address

The Chairman welcomed the Councillors and members of the public.

The Chairman introduced and welcomes our new Councillor, Debbie Williamson, who joined the council today, and signed her Acceptance of Office.

2. Apologies for Absence

4. Minutes from the Meeting Held 1st February 2024

The Minutes were accepted by the Council, proposed by Cllr Oughton and Seconded by Cllr Crisp.

5.Matters Arising

a. Bellway estate. Cllr Willis reported that

After the last Council meeting I sent an invite to DBC planning representatives, Michael Conyer and Dave Coates to come to the Bellway development to discuss outstanding planning issues

I have not received any response from them – however I copied in Bellway directors inviting them to be involved

I eventually received a response from their MD Frank Lincoln who apologised for the delay in completing outstanding issues and informed me that he is holding a Technical Review and will get back to me once he has clarity. He did indicate that there is an issue between the LA Highway inspection manager and Bellway te4chnical team.

This e mail was received on the 16th February – I have had no response since

I e mailed the MD last Thursday asking for an update and inviting him to our meeting – no response to date.

Two members of the public expressed their concern about the lack of action being taken by the Bellway management, and also the lack of any response from Darlington Borough Council.

Cllr Willis told the meeting that he will escalate the issue, and continue to pursue both Bellway and DBC. Action Cllr Willis

6. Hurworth Grange Lease

The Chairman reported that the six councillors have now submitted the credentials to the solicitor, so the lease can now be drawn up. There are two items still to be agreed between the two parties. The termination clause, and the definition of 'All repairing' lease, which may need some revision. The solicitor is drawing up the draft, and it should be concluded this month. **Action Cllr Leigh.**

7. Ward Councillors Report

Councillor Lorraine Tostevin reported: -

- 1) The Highways works being advertised on notices on Roundhill Road are to extend the full length of the Road. The scheme has not been fully designed yet but it will include filling of potholes, haunching and resurfacing as so required.
- 2) The entrance on Neasham Road (opposite Strait Lane) which is currently with planning for determination as a retrospective application has had some drainage works progressed in order to reduce the flooding in that area.

3) Funding for Hurworth Schools was signed off at DBC Cabinet this week. The funding is for educational improvements and has come from Miller Homes. This funding does not include the monies for the 20 mph scheme outside Hurworth Comprehensive that is expected later this year subject to approval of the design of the scheme

8. Annual Assembly

The Annual Assembly, which is a Public Meeting, hosted by the Parish Council will be held at Hurworth Grange on Friday 12th April stating at 6.45pm.

The first section will be short presentations by community groups, highlighting all of the many amenities, families and community events which our vibrant village embrace.

The second session is open to the public, who can make any suggestions, put forward any ideas, and make observations, all of which will be taken into consideration when the Parish Council formulate the Parish Plan for the next three years. There will be a free buffet and free bar, and it is hoped that at least 100 residents will attend. There will be amble advertisement of the event.

9. Public Participation

- 1. A resident asked if the council had identified the pathway which runs from the Glebe to the railway, backing the Grange. Cllr P Williamson said that this is still not clear, but StreetScene are making further enquiries.
- 2. A trustee of the Rogers Trust addressed the meeting, and explained why the Trust exists and that their mission is to provide grants to both individuals and =community groups, who are within Hurworth Parish, and who are in need of assistance. Each application is considered on its worthiness for the financial aid.
- 3. A resident asked about plans for new housing estates in Hurworth. He had heard that planning permission has been submitted for more houses on Roundhill Road.

Cllr Tostevin responded and explained the DBC has a 15 year Plan, which is now into its third year. The Plan states that Hurworth will not be required to have any more major houses built, except for infills, on a case-by-case application. There have been applications for further development, but there have been and will be denied, as they will fall outside of the DBC Plan. However, the Plan is reviewed every five years, but at present this is the situation.

10. Planning Applications

Cllr Willis submitted the following report: -

A resident raised the question about the rerouting of the pathway at Timmies Lane.

Cllr Tostevin said that this was now being addressed at the Planning Department, that the matter should be resolved within the next month

Councillor Reports

11. Tree Report

Cllr Foster reported: -

All the trees have been inspected, and despite rain and strong winds. the trees and in good health,

The trees in Goblins Wood have been cut back to allow the light from the street lights to function more effectively.

The inspection of the trees in the Grange has identified two large trees which are dead, and will need to be felled. We are waiting for the ground to dry out, to make the felling of the trees both easier and safer.

12. **Open Spaces** – Cllr Lennox gave the following report: -

Open Spaces and Environment - Fiona Lennox - March 2024

Environmental Agency

As discussed at the last meeting on 1st February, we had a request from the Environmental Agency for the work on the river near Croft, for the installation of new equipment. HPC unanimously agreed to give permission for this work to commence but only with the proviso that we had a written statement from EA that we would have no liability for the new installation either during installation, or in the future. So, we now have a letter from the Environmental Agency clearly stating that they take on the liability in the event that any incident occurs.

Point of note – EA actually have legal authority to enter our land, with or without our permission but did ask us for permission.

Waste Bins Update

Also, as mentioned at the last meeting: -

- The waste bin at the Green, with the hole in the bottom, has now been replaced DONE
- Still discussing the need for a bin at the layby at Hurworth Place going towards Darlington, where there used to be one but there isn't one currently.

Village Flowers

Nigel Goddard, who buys the plants and looks after the planters at the Village Hall, near the Comet notice board and at Hurworth Grange, asked if he could spend a little more money this time compared to previous years. This is because he wants to buy different types of plants that require less watering during the dry summer months. We have agreed to this as it makes sense to have easy to maintain plants in these public areas.

Also, we would like to take this opportunity to thank Nigel for the work he does in the village. Nigel carries out all this work voluntarily and has done for several years now.

Tees River Trust

In the past we have contributed £1000 each year to Tees River Trust. TRT spray the hogweed twice a year, plus extra if we request it. HPC covers the stretch from the Ringfield to Newbus Grange.

Can we continue to do this? It comes from the Open Spaces budget.

A motion was tabled by Cllr Oughton, seconded by Cllr Forster that the council will contribute £1000 to the Tees River Trust to assist funding for the Giant Hogweed removal. The motion was passed unanimously. **Action Clerk**

Civic Pride - Anti-Litter Campaign

Not specific to Hurworth, but Civic Pride have advised us of an upcoming anti-litter campaign, "The Big Spring Clean". This is their annual anti-litter campaign run in conjunction with volunteers and partners and aims to encourage us all to take pride in where we live, work and play, by way of litter picking the local area.

14. Rights of Way Report

Cllr P Williamson reported as follows:-

Footpath update for 7th March 2024

Footpath 11 (Teesdale Way) section from Blind Lane to the Hotel complex.

This section of footpath is suffering badly with flooding, due to the field on one side and the owner's driveway on the other, being higher than the footpath. DBC are in discussions with the landowner, about the driveway. We are awaiting a further update from DBC.

Footpath 19

This short piece of path that runs off Croft Road, opposite Elmfield Road and up to the Grange playing field by the dog bin.

Peter Allen and Peter Williamson had a meeting with Brian Graham (DBC) about this issue and what could be done to resolve the problem. We have not received any feedback from our discussion.

Also, we have decided to investigate further options to rectify the problem and will be contacting some drainage consultants for information and estimates on how to rectify the fault.

Footpath 9

Peter Williamson has been asked by DBC Rights of Way Officer to revisit this footpath in the small wood section, this is due to fallen trees/branches that are causing walkers to bend double to pass.

Although the DBC has sent letters asking the landowner to rectify this issue. There has been no response.

Also, I have reported back to DBC Right of Way Officer that nothing has been done to rectify the reported issue.

Dog Fouling

The DBC Right of Way Officer has just supplied me with some stickers to fix where necessary, asking residents to pick up after their dogs defecate.

17. Roads and Pathways

Cllr Forster, said that there is nothing to report for February, except one resident has asked for potholes in Greenside Court to be filled in. The Council agree that this will be carried out. Action Clerk

18. Projects 2023-24

- **a.** Beech tree carving project Cllr Forster reported that the project is now getting underway, and the group is encouraging the scouts and Hurworth House school to become involved. They are seeking further funding from an Arts Fund. They are meeting with the Clerk next Tuesday to make further plans.
 - Cllr Crisp suggested that they involve one or two local companies, who could provide material and give assistance. Cllr Forster said that they want to keep this as a community group, and develop skills and interest for the members of the group.
- b. The Grange pathway entrance Cllr Williamson reported that he has project has been discussed with Mr Brian Graham; Head of StreetScene and they had discussed various options regarding the drainage on the field. The option to move the entrance has been dropped, as there are further complications and few benefits, The suggestion of a small bridge appears to be the better option, and further consultation with civil engineers and obtaining quotations is in progress. Action Cllr P Williamson & the Clerk.
- c. Cllr P Williamson drew attention to the deterioration of the pathway bordering the Grange nature reserve. Some maintenance is required. Action Clerk

19. Matters of Interest

- a. Council Notice Boards The Chair reported that the three new notice boards have arrived, and will be installed later this month. The Durham dioceses has not yet replied to our request to replace the notice board in the church grounds. Actions Clerk
- b. Potholes at Greenside Court this will be addressed.
- The Council has prepared the next edition of the **Parish Chronicle.** This will be going to the printers on 9th March, and will be delivered. Along with the Church newsletter on or about 20th March. The Chronicle features the upcoming Annual Assembly, and the articles within, highlight the vibrant nature of our beautiful environment.

1. The Chairman requested permission to match fund the Rogers Trust in providing £750 as a Section 137 award to fund the new pétanque disabled friendly pathway. Cllr Oughton proposed contributing the £750, and Cllr Forter Seconded the motion. The motion was passed unanimously. **Action clerk**
