Minutes of the Parish Council Meeting held at Hurworth Grange on Thursday, 7th March 2019

163. Chairman's Address

The Chair, Paul Walters, opened the meeting and welcomed the Councillors and members of the public.

The Chairman drew attention to the forthcoming election, when all current councillors who wish to stand again, must make a formal application.

Several councillors will not be standing for re-election, so it is important that new residents are encouraged to put their names forward.

The election timetable is:-

- 18th March Publication of Notice of Election
- 18th March Publication of Nominations- Candidates application forms will be available from the Town Hall
- 3rd April Withdrawal of Candidates
- 3rd April Appointment of Election agents
- 4th April Publication of Statements of Persons Nominated
- 12th April Last Date of Registraion
- 18th April Receipt of Postal Vote Applications
- 2nd May Day of Poll

The Chair asked Cllr Joe Kelley to introduce his guests who will be addressing the Council to update the status of Super High Speed Broadband in Hurworth.

Representing TVCA: Keith Wilson Representing DBC: Jochen Werres

Keith Wilson TVCA talked through the process of rolling out High Speed Broadband infrastructure throughout the Tees Valley with public funding to accommodate 98.1 % percent premises in each Tees Valley Local Authority including Darlington. Adequate funding has been set aside by the Tees Valley Combined Authority to accomplish this

matched by government funding of Broadband Delivery UK.

However in November 2018 BT Openreach and BDUK who were earmarked to deliver the 98.1% coverage in rural and urban Darlington including Hurwort h and Hurworth Place concluded that for the future infrastructure upgrades have to fulfil future proof Fibre to the Premises (FTTP) technology and ruled out on Value to money reason envisaged and modelled roll out in Darlington via Fibre to the cabinet (FTTC) technology.

Those Fibre to the Premises (FTTP) broadband provision make dense urban locations more attractive to serve than smaller density rural communities.

Hurworth and Hurworth Place and other rural locations in Darlington have been ruled out to be connected by the full fibre solutions due to cost and lower take up figures which effect vaibility.

Tees Valley Combined Authority and Darlington BC are keen to achieve the 98.1 % coverage in Darlington and through different technical solutions and budget would like to achieve this by end of 2020 to cover minimal speeds of 24Mbits. This would be delivery a year later than planned (target was Summer 2019) and would not guarantee Gigabit or 5G enabled speeds. But TVCA may have resources in reserve to accomplish through a rollout process of superfast Broadband in Hurworth and Hurworth Place.

Following a question from a resident, it was confirmed that the schools already have high speed broadband access through dedicated lines. As in Urban areas rural residents connected to broadband are required to pay for their broadband connectivity but current speeds would be enhanced to a contemporary standard which would enable streaming and use of modern digital applications.

Cllr Kelley ended the discussion on a positive note saying 'Faster Broadband will be coming and enabled in Hurworth and Hurworth Place'

Cllr Kelley ended on a positive note saying 'it is coming'.

165. Public Participation

a. A resident enquired if there was any progress on the plans to enhance the children's playground.

Bree Stamp responded, informing the meeting that good progress has been made which includes:-

- A group of interested residents has been formed
- A survey has been prepared and will be distributed this week
- The survey will be put on Facebook, inviting comments, ideas and support
- Posters will be put up advertising the scheme and canvassing support
- A budget is being prepared
- Grant opportunities have been identified, and once support is quantified, applications will be made.
- b. A resident drew the attention of the council to a housing application to build a house at the top of coach lane. The lane is very narrow, and the entrance form the main road

is not conducive to traffic. A few vehicle use the lane, but problems could occur if another two vehicles will be using it on a continuous basis.

Cllr Peter Foster informed the meeting that Coach Lane is actually designated as a bridal path and not a road. The surface is not constructed for vehicles as it was laid to accommodate horse drawn vehicles.

The Chairman thanked the resident for bringing this to the council's attention. Cllr Tostevin said that she will make further enquires.

166. Minutes of the Meeting held on 7th February 2019 were accepted, Proposed by Dorothy Oughton, Seconded by Eli Hedley

167. Matters Arising

a. Hurworth Parish Entrance Plaques

Paul Walters reported he had held a meeting with Bellway, and that their bricklayers will install the three plaques.

The locations have now been selected, one at the village entrance on Roundhill Road, one on the grass area coming into Huworth from Neasham, and the third beside the parish notice board near the Comet Inn.

The material selected for the framework will be Chelsea Smoke Brick.

A senior bricklayer from Bellway will be overseeing the installation, and will use their current Apprentice Scheme to participate and thus reduce the cost to the council.

Bellway will make the planning application for the plaque placings.

168. Planning Report.

Richard drew attention to the application which was discussed during Public Participation, which involved the construction of a dwelling in Coach Lane.

The Council further discussed this application, particularly highlighting Cllr Fosters observations about it not being a designated road.

It was decided that the council should lodge a formal objection. Action Clerk and Council.

Cllr Tostevin offered to make further enquiries regarding the status of Coach Lane.

169. Neighbourhood Plan

Tony Winnett reported:-

Following the Public Meeting held on 31st January, the comments were evaluated and appropriate changes made.

A meeting has been held with the DBC Planning team who are validating the Hurworth Plan.

A number of modifications were suggested, and these have now been made, and a revised Green Area map has been prepared.

The revised report has been sent to DBC, and the next step is a further meeting to try to finalise the Plan.

Following this, we need to send details to all businesses, utility operators and other stakeholders, providing them with an Internet link, so they can read our Plan. This involves a six week consultation period.

On completion of this, DBC need to perform several additional processes prior to them sending out the Referendum to all Hurworth residents.

It is a long, somewhat tedious program, and it is now likely that the Referendum will not go out until June 2019. We understand that DBC have not actually completed a single Neighbourhood Plan as at this date.

170.Tree Report

Peter Foster commented that Hurworth has a huge amount of beautiful, well-established trees. However, some residents have made complaints that the trees are potential dangers to their houses. The trees in question have been there before these people purchased their houses, so it could appear that they were fully aware of any potential risk when they received their house survey, prior to agreeing a contract.

Peter Foster reported that he has made his customary inspection of all the trees in the village again in February and the trees are in good condition. One branch had to be removed a tree in Hurworth Grange.

171. Open Spaces report

Wilma Campbell reported as follows:-

a. OPEN SPACES

The Open Spaces audit has been updated and completed. It will be available for perusal on HPC website.

From a concerned resident.

"As Open Spaces person on HPC I would like you to request that this topic is placed on the agenda for the next meeting with a view to HPC subscribing. The reason is that it is an excellent local wild life magazine and there is nearly always a project(s) worth considering, initiating and supporting. For example, in the recent issue No. 24 there is an article given over to a farmer who utilises 10% of his land for flora and fauna. HPC could take the lead locally in such an enterprise and approach local farmers with the example and information. Joining Tees Valley Wildlife Trust would, I think, set a good example locally, many good ideas could be gleaned and many initiatives could be taken with a degree of local authority, It would be a good example of how HPC is looking after the welfare of the parish.

There's also the RSPB, the National Trust, Peoples Trust for Endangered Species, Woodland Trust, all of which produce excellent magazines with many good articles, many of which could be considered for local use. For very small membership fees I think it would be an excellent example of how HPC are trying to be aware of initiatives which can help the local environment and flora and fauna in particular.

It would be nice to get a realisation from HPC that it is their responsibility, particularly in this day and age, to recognise the importance of such projects, apply them parish wise and hopefully prod the likes of DBC, especially when they are poised to chop down another 83 trees at the Blackwell Meadow development, even after the furore last year. At least HPC have planted two oak trees, meagre as that seems in comparison, but are still to be congratulated."

b. EPICH

We have had lots of positive feedback from residents regarding our planting of bulbs around the village. Thanks to All Saints churchgoers who are responsible for the lovely display of bulbs on the Green.

At the Grange, EPICH cleared the area around the cherry tree close to the picnic tables.

Our thanks to Cllr. Foster who coordinated with DBC for the Community Working Party to clear the raspberry canes on the east side of the football pitch enabling daffodil bulbs and other native wildflowers to flourish.

As the step over apple trees grow they are being trained across the wire.

The bird hide feeders are being replaced as required.

Over the next few weeks some fruit trees in the Heritage Orchard will be pruned.

EPICH bees have survived the winter and the colonies are building up. Hopefully there will be lots of our local honey for sale at the Hurworth Festival on Sat. 15th June.

c. Giving nature a home.

All swift boxes have been sold to village residents.

We hope to place bat and bird boxes in Hawkswood area before the start of summer.

We have been given the opportunity to acquire 6 crab apple trees which are an excellent food source for birds over winter. We hope to find suitable areas to plant these.

172. Hurworth Festival

The Chairman informed the meeting that a festival was being organised to celebrate the 50th Anniversary of the Hurworth Community Association. Peter Allan, Chairman of HCA was invited to address the Council.

Peter described how the intention is to bring all the community groups in Hurworth together to stage a festival which will take place on Saturday, 15th June and will cover the village from Hurworth Grange to the Otter and Fish Inn.

The event will incorporate the Scarecrow Festival and re-create the Strawberry Fair, which sadly met its demise two years ago.

Two bands, two dance troupes and a variety of entertainment is being organised, with seven community groups participating, each organising their own exhibits or fund raising events. There will be no entrance charge and parking will be £1, parking will be at the Grange and possibly also the Manorfield. Disabled parking is available at the Priory Hurworth House School.

In order to help to fund the festival, the Council were asked to award £2,000 under the Section 137 allowance. The Chairman tabled the motion to make a £2,000 award, Seconded by Tony Winnett, and the motion was passed unanimously.

173. Allotment Report

Nic Prior reported that

He has done a tidy up on and around the paths surrounding the allotments at Strait Lane. There was some evidence of dog poo.

There are three allotments vacant at strait Lane and one at Hurworth Grange. These will be allocated to the applicants who are on the Waiting List.

Highways and Traffic Reports

Margaret Williams reported as follows:-

a. Highways report for February 2019 - HPC 7th March meeting minutes

Max speed 80 mph on 9/2/2019 @ 22.45 (probably same vehicle recorded as travelling from Lindon Court area on that day and time)

Ave speeder travels at 33.1 mph in the 30 mph limit

Roundhill Road incoming

Note:- there has been traffic light control on the road on approach to the monitor for some days in February Vehicle count 43,363

Max speed 60 mph on 15/2/2019 @, 05.15

Ave speeder travels at 32.9 mph in the 30 mph limit

% drivers over 30 mph limit= 13.3%

Again the speed monitor showing the highest values is the one outside Hurworth School on Hurworth Road! This is reported every month and does not change.

Broken "no parking on the Green "signs have been repaired and replaced.

The edges of the verges on the Green are showing considerable damage caused by delivery drivers, contractor's vehicles and inconsiderate parking on the internal roads in spite of these notices!

b. SpeedWatch

Elaine Hedley reported that two sessions had been held in February and ten percent of the vehicles clocked were over the 35mph limit, (which is the criteria to which they operate). The registration numbers have been passed on to the police. Bad weather had restricted the monitoring to only two sessions.

The Clerk raised a question regarding an outstanding item, when the Council requested that we install concrete bollards along the roadside from the Mustard Tree towards the Grange. He expressed concern about the need for parking in this area, and doubted the wisdom of making a permanent blockage, when damage is only done to the grass area during the winter when the weather is very wet.

Graham Wylie suggested tarmacing the verge area.

Wilma Campbell expressed her concerns that if the grass area is removed and effectively the pathway would extend to the busy road, it would become dangerous for young people and people tending young children.

The meeting decided to give the matter more consideration and to put on hold the installation of concrete bollards. Action: Further consideration.

174. Matters of Interest

a. Insurance Claim

Margaret Williams advised the meeting that the Council has received notice of a possible claim for two very old and well maintained oak trees sucking water from under a resident's house. The Council have passed the details to Zurich Insurance, and will be contesting this possible claim.

b. Installation of a defibrillator

Tony Winnett reported:-

A training session was held at Hurworth Grange on 28th February. This was well attended by almost thirty people, all who now have a reasonable understanding of the purpose and operation of a defibrillator.

The second defib unit is about to be ordered and will be situated next to the bus stop outside All Saints Church. DBC are going to install a post, and this will provide power for the unit. A 'guardian' for the new unit has been appointed, and will oversee that the unit is kept operational.

A third defibrillator, which is to be purchased by Rogers Hurworth Charitable Trust will be located near the Croft Club and Comet Inn.

c. No Cold Call Zones

Wilma Campbell made the following address to the meeting:-

"NO COLD CALLING" ZONES

Public Survey - Doorstep Traders/Callers

(Report by Trading Standards Institute 2003)

This survey of the public's attitude to cold calling at the door was conducted by questionnaires, which were delivered to several thousands of households across the UK. Close on 9,000 questionnaires were returned providing statistically significant results.

The findings indicated that only one in a thousand respondents indicated that they welcomed doorstep sellers and 95.7% said that they do not want doorstep sellers calling. Sixty-one point five per cent said they had been visited at least once in the previous 12 months and 22.6% reported being called upon 3 or more times. Energy selling and double glazing came out highest, followed by house wares.

Ten point five per cent of respondents specifically said they had a bad experience with doorstep sellers during the previous 2 years, but a follow up question asking what type of product/service people had problems with suggested that this figure might be much closer to 26.6%. Only 1 person in 6 who reported a problem reported the matter to the authorities.

When respondents were asked if they could think of any benefit which doorstep sellers bring to you or householders in general, of those who answered the question 96.2% replied and emphatic "no".

No Cold Calling Zones

If your street suffers from the nuisance and criminal consequences of rogue traders knocking at yours and your neighbours' doors you should get together with them and approach the council's Trading Standards department to see if they can assist in setting up a No Cold Calling Zone. A No Cold Caller Zone is a designated area where the resident community declare they no longer wish to accept traders calling at their homes without an appointment. They operate in some parts of the UK and the designated area is marked with street signs that tell doorstep traders that they are not welcome. They clearly indicate to the trader that the residents are aware of their practices and look out for each other. Evidence from a number of councils who operate the scheme suggests that people feel more confident about saying "No" to cold callers in a No Cold Calling Zone and more importantly the number of cold calls does reduce. Residents are encouraged to keep an eye out for each other, use crime prevention measures at the door and report details about cold callers working in the zone to the local trading standards and police

Trading Standards worked in partnership with Durham Police to set up No Rogue Trader Zones within Darlington.

A No Rogue Trader Zone is a clearly defined area where residents have expressed a view that they would prefer not to be cold called at home by traders selling goods and services door-to-door. The aim of the zones is to give residents the confidence to say NO to uninvited salespeople and to warn rogue traders and cold callers that they are not welcome.

Darlington has three zones covering the following areas:

- · High Coniscliffe
- Fryer Crescent

• Barnes Road, Barnes Close, Kew Rise, Mowden Hall Drive, Conyers Avenue, Conyers Grove and Chester Grove

Due to the continued complaints from residents about doorstep cold calling, I think HPC should look into this matter with DBC's Trading Standards in more detail, consult with residents to identify areas of concern within the Parish and then decide on the action needed.

This would be a project for the new council to take forward. Action: Further discussion.

d. Friends of Rockliffe Court

The Chairman read out a letter from the Friends of Rockliffe Court requesting some financial assisting for their project of maintaining the gardens at the home. It was agreed that this cause should be supported, and a motion was tabled by Tony Winnett, seconded by Wilma Campbell, that a Section 137 award of £300 be made. This was passed with 11 votes in favour and one abstention.

175.Police Report

a. Janine Forster stated that the next walk would be on 21st April, and another was being arranged for 9th May.

b. Graham Wylie reported that he had held a meeting with Steve Petch, DBC Countryside, and he has now completed the draft brochure covering the Hurworth and district walks. Graham distributed copies of the draft brochure, and the meeting agreed it is an excellent document.

Graham has not 'walked' every one of the walks covered, and recommended that Janine Forster does check the details and directions which are embraced in the brochure.

Once the accuracy has been verified, the council intend to print 200 copies and make them available in the parish. The Chairman thanked Graham for his single-handed work on this project.

177. Parish Chronicle

Elaine Hedley reported that all the information was now to hand, and the newsletter was being compiled. It should be ready for proof-reading and taken to the printers early next week.

It will be delivered along with the Church Newsletter before the end of March.
