

## Minutes of the Hurworth Parish Council Meeting held on Thursday 4<sup>th</sup> January 2024 starting at 7:00pm at Hurworth Grange

## 1. Chair's Opening Address

The Chairman welcomed the Councillors and members of the public.

The Chairman announced that Cllr Charlotte Marie Kay has resigned from the Council; Her new career move is proving to be taking a lot more of her time, ads she does not feel that she can continue to make a constructive contribution to the council at this time. The Chairman expressed his thank to Charlotte and wished her good luck.

## 4. Minutes from the Meeting Held 7th December 2023

The Minutes were accepted by the Council, proposed by Cllr Oughton and Seconded by Cllr Crisp.

## **5.**Matters Arising

- a. **Bellway estate.** In the absence of Cllr Willis, there was no formal report. However, a resident, who olives on the Bellway estate, addressed the meeting. He confirmed that Cllr Willis was trying very hard to get the Bellway management to fulfil their estate obligations, but was receiving no satisfaction. He, himself, has been raining the issues, and intends to escalate the situation to a higher level. The general feeling on the estate, is that Bellway have not fulfilled their commitments, and have left the estate unfinished.
- b. **Potholes on Village Green** In accordance with the decision at the last meeting, the potholes will be filled in. The work is scheduled to be carried out on 10<sup>th</sup> January, weather permitting.

## 6. Hurworth Grange Lease

We have approached four firms of solicitors, and three of them have submitted cost quotations for the drafting of a new property lease. All were given the same information and background.

Having considered each quotation, and details provided, the Council has selected Latimer Hinks, who are based in Darlington, and whose submission is attractive. **Action Clerk to respond to al the bidders.** 

It is now necessary for HPC to have a meeting with Hurworth Grange CIO in order to agree on the terms of the lease. **Action Cllr Leigh and Clerk.** 

## 7. Ward Councillors Report

1. Cllr Walters reported on the latest situation with the construction work being carried out on Neasham Road and the detrimental effect it is having on the flooding at the top of Strait Lane. An application has been submitted requesting permission for access to Neasham Road, but until the decision is made the gates must remain locked.

DBC Highways have written a strong letter to the constructors ordering them to make good the blockage of the water channel at the top of Strait Lane. Failure to comply will mean that DBC will carry out the work and invoice the constructors.

Cllr Crisp commented that the flooding in the area at the top of Strait Lane is the worst he has ever seen it, and it is doing damage to the road surface. There is a huge pothole, which needs urgent attention. **Actions DBC.** 

- 2. Cllr Tostevin reported that a letter has been sent to accelerate the creation of new bus stops at Neasham. Two new bus stops have now been installed at the Tawny Owl inn.
- 3. There has been consultation regarding the situation of the Right of Way at Rose Villa. This is progressing.

## 8. Public Participation

A resident addressed the meeting and outlined a number of serious complaints and limitations of the current bus service, as it affects the residents of Hurworth Springs Country Park. The buses are unreliable and often very late. A system of 'Hail and Stop' has been introduction, but in practice this is not consistent in operation, as some buses are not responding.

The resident expressed his frustration of not knowing who is in overall responsible for the bus service, and he, himself, is writing to the mayor, to try to get the service improved. He went on to state that the existing bus service is 'unusable', and can take 45 minutes to get from Hurworth to Darlington, and there are cases when passengers have had to get taxies to get home.

Also, some bus stops have been removed from the list of new ones proposed by Stagecoach, while others, which have been requested, have not materialised. Action Cllr Tostevin offered to pick up this challenge, and help to improve the service.

## 9. Planning Applications

Cllr Willis submitted the following report: -

There were two significant applications submitted in December 2023, viz:-

**Darlington Borough Council** 

Planning Application REF 23/01240/FUL

Newbus Grange and caravan site,

Demolition of existing single storey extensions and fire escape stairs to the rear to allow for conversion and refurbishment of former nursing home to create offices at ground floor level and 6 self-contained flats to first and second floors of main building with the provision of bin store and increased cycle storage. Creation of new vehicular access road and refurbishment of hardstanding to create 23 parking spaces. Extension of existing caravan park to provide 70 additional spaces including 6lodges and 16 touring pitches, formation of 2 ponds, jogging / exercise trail, planting of woodland to north of site and reconfiguration and landscaping to original site.

## **Planning Application REF 23/0111/FUL**

Skipbridge Farm, Neasham Road, Hurworth Moor.

Variation order to convert 8 redundant agriculture sheds and conversion of barns into 8 dwellings, with associated parking and landscaping.

## 10 Tree Report

## Cllr Foster reported: -

Although there have been some severe winds, the trees in Hurworth have fared well. There have been a few broken branches, but nothing serious. He believes that this is because of the constant inspections being made, and the diligent upkeep of the trees,

Two large sections of a tree on the pathway between Couch Lane and Hurworth House School have been taken down. The branches were overhanging the street light fer number 287, and stifling the light. This work has been done and the result is excellent.

The three cherry trees, which we ordered in April, will be delivered this month. There was a slight delay caused by the bad weather. The trees will be planted near the miniature railway, to replace the trees which were removed at the beginning of the year.

## **Cllr Dorothy Oughton reported:**

#### a. Traffic Report

The monitor at Metal Bridge, will be repaired in January. Swarco have subcontracted the servicing to a national company, who do not have local engineers. Hence the cost of a repair is very high. We have made other arrangements, which will make it much easier and less expensive.

Residents reported that the chevron at Hurworth Place has been damaged. Also, the sign at the waterworks has been damaged. Action; **Cllr Tostevin** offered to report these incidents to DBC.

#### **REPORT:**

Follow wide gravel track to stile 1 this track is all good. However, this track is also used by cars giving them access to their garages.

#### STILE 1

Stile 1 and signage in good condition. However, stile 1 is not used due wide entrance to field has been left by farmer ungated.

This track has now become a path, which is clear and free from any debris. Continue along the path until reaching stile 2.

#### STILE 2

Stile 2, along with signage, both is good condition and stile is dog friendly.

#### STILE 3

Step 3 step rotten, along with signage, both steps and signage need replacing.

Pathway behind manor road estate, between stiles 3 - 4 completely under water by about 3-4".

#### STILE 4

Stile 4 completely rotten, although there is an open space at the side of it, allowing walkers to be able to continue along the path to railway bridge. Picture at bottom of report.

#### STILE 5

Stile 5 good condition and dog friendly. Signs are faded and need replacing.

#### STILE 6

Stile 6 in good condition and dog friendly. Signs need replacing on one side as they

are unable to be read.

## STILE 6 – TEES VIEW

From Stile 6 there are no signs to indicate the public rights of way across the farmers track, to be able to pick up the path again, ending at Tees View.

ROAD NAME/PATH: - BURMA ROAD - YARM ROAD

**REPORT:** 

At end of Burma Road leads to bridleway, bridleway is overgrown with trees which need cutting back, as walkers or riders will have to duck under the trees to continue along

path/bridleway. Making it extremely difficult to continue for the first 50 metres.

There are signs indicating (Salters Lane) Bridleway. The metal sign is completely broken and the bridleway signs are faded and need replacing. Pictures at bottom of report.

Follow bridleway to A66, there are 2 posts and a large bolder which stops vehicles from using the bridal way, riders/walkers do have access. There are no signs indicating the continuation of bridleway from this point forward over the A66.

Having crossed the A66, the bridleway continues past a large boulder, but there are no signs at all to show continuation of bridleway.
