

Minutes of the Hurworth Parish Council Meeting held on Thursday 7th September 2023, starting at 7:00pm at Hurworth Grange

1. Chair's Opening Address

The Chairman welcomed the Councillors and members of the public.

- a. Councillor Roles
 - The Chair read out the list of roles which the Councillors have agreed to take on for the next 12 months.
 - The role for addressing Youth activities has not been filled, and there is one Councillor vacancy which is being held open so that a suitable volunteer can be co-opted.
- b. The Parish Council hold a surgery at 6:30pm immediately before the monthly meeting. Members of the public are invited to drop in and raise any topic they may wish to discuss. Two Councillors will be in attendance.

4. Minutes from the Meeting Held 7th September 2023

The Minutes were accepted by the Council, proposed by Cllr Oughton and Seconded by Cllr Forster.

The Minutes of the HPC Special Meeting held on 7th September 2023; proposed by Cllr Oughton and Seconded by Cllr Forster, were accepted.

5. Matters Arising

a. Twenty mph limit on Hurworth Road consultation

Cllr Tostevin reported that Andy Casey, DBC Highways, was still considering a few points, but expected to conclude the outcome by the time of our November meeting.

b. Bellway Estate

Cllr Willis reported that he understood a new contractor had been engaged to complete the outstanding work, A new contractor has, in fact, been seen on the estate. There are a number of issues still to be resolved before the site 'sign off' can be agreed. Cllr Willis agreed to continue his dialogue with the Bellway management, to ensure the estate is left in the condition of the contracts.

c. Village Green potholes

The Clerk was asked to update the meeting with the situation regarding the pothole. An assessment has been made by Cllr Russell, who has stressed that this is quite a big undertaking, if the repair is to be long-term sustainable. An estimate of the cost to dig out and resurface the specific area where the pothole is located, will cost circa £2,000, and if the larger area, to encapture the whole of this short internal road was resurfaced, it would cost circa £4,000.

The Village Green has no known owner, and hence nobody or organisation has responsibility.

The parish council had agreed in 2022, to allocate £1,000 each year as a gesture, to keep the internal road within the village green tolerable for vehicles. The council must now decide whether to keep to the £1000, or to increase the amount for this specific project. After an open discussion, a motion was tabled, proposed by Cllr Forster and Seconded by Councillor Foster ??? that the Council should allocate upto £4,000, and to obtain three quotations, to meet the specification of the work required to complete the larger segment. The motion was carried unanimously. **Action Clerk**

d. Parking around Hurworth school,

The Chairman informed the meeting that the Headmistress of the school has sent a letter to the parents requesting them to park responsibly and try not to cause congestion or block resident access. The chair is optimistic that this will alleviate the problem, at least ease it.

e. Minutes recording query

The Chairman informed the meeting that the Minutes date 6th July 2023 have been modified, in accordance with the request made by a resident.

6. Ward Councillor's Update

Cllr Walters and Cllr Tostevin reported: -

- a. Solar Farm, Cllr Tostevin stated that there was No update to report.
- **b.** New Houses in Hurworth Cllr Tostevin informed the meeting that there will be a further 144 private houses built behind the new Elderbrook Estate which is opposite the arena on the A66, approx 350 houses of the houses on this large site are within Hurworth Parish and are identified in the Local Plan.
- c. Spar shop incident –Cllr Walters had been in attendance when a PCSO was reviewing the parking times at the Spar Shop following a recent accident at school time. Cllr Walters was advised by the PCSO that the enforcement team would be asked to monitor the parking situation going forward. The Spar shop however, were surprised to find that a "no loading" sign had been placed outside the shop to prevent loading between 8.30 and 9.15. The Spar shop had previously requested help from the parish council in relation to loading taking place further up the road however, this had not happened. It was difficult for the Spar Lorry to attend at any other time of the day, and the Shop would appreciate a further discussion with the Parish Council to see if a solution could be found. Action The Clerk to contact the Spar Shop to arrange a meeting.
- d. A new private road Cllr Walters reported that a new road has been constructed off Neasham Road, alongside Skipbridge Garage and this had taken place without planning permission and an amount of damage has been done to the hedge and roadside. DBC have again requested those responsible apply for retrospective planning permission and in the interim stop all work and make good the land, and a deadline has been set for this to be completed.

Cllr Foster stated that a heavy chain has been put around a style to prevent use. It was agreed that Cllr Russell will be asked to cut and remove this and make the style safe **Action Cllr Williamson**.

7. Public Participation

- 1. A resident stated that reference to a motorbike had been included in the September Minutes AOB 20.2. She stated that it was not a motorbike. The clerk will check exactly what the 'item' was, and correct the Minutes accordingly.
- 2. Two residents expressed their concern about the possible plan of constructing a fishing platform on the riverside opposite Tees View. The chair explained that, at this stage, it is only a suggestion which has been put forth, and no further developments have taken place to date.
- 3. A resident stated that there were still pipes lying about near the kissing gate in Hurworth Grange. Action Clerk will get them removed.
- 4. The same resident started to list several other concerns which he wished to raise. The Chair asked him to stop and proposed that if there were a lot of questions that the resident write to the council, prior to any future meeting, so that appropriate answers can be prepared for him and that would then make the meeting more productive.
- 5. A resident stated that the roads and pathways on the Bellway estate are still not completed. The Agreement stated that all this work would be completed by Quarter 3 2023. Cllr Willis reiterated that he would arrange to talk to Bellway and to include this in his discussions. **Action Cllr Willis**
- 6. Cllr Williamson introduced a resident who has a problem relating to a footpath, on his land. The property and land which he has recently purchased need to be wheelchair friendly for his family needs. He has made suggestions about an alternative route for the footpath. Cllr Williamson has agreed to assist the resident to try and find a satisfactory resolution. Action Cllr Willimson.

10. Trees – Cllr Foster & Cllr Lennox

Cllr Lennox gave the following report: -

Tree Report September 2023

I am pleased to have recently started with assisting Cllr Peter Foster with the monitoring of the trees in the parish.

I have a copy of the **HPC Tree Policy** and am starting to understand the basics of monitoring all the trees in the parish, most of which are within Hurworth Grange.

I have also got a copy of the **Tree Surveys carried out in January this year**, and during the next month I should be able to locate them from the maps provided. I am sure Peter Foster will give me guidance.

Update: -

- During September we have cut potentially dangerous branches from the lime tree outside numbers 31 and 32 the Green, which is on the north side.
- We have also heightened the canopy of the trees on the side of the internal roads on the Village Green. This will allow traffic to pass without hitting the lower branches.
- There is a **tree on the roadside in Emerson Road**, which the resident has reported as causing problems both with the long branches and with the root, which is starting to disturb the pavement. We reported it to DBC, and StreetScene visited and cut back some of the overhanging branches. The resident next to the tree complained again and asked for further work to be carried out. The response which we have received from the Head DBC arborist is as follows: -

'There is no other work required to the tree Mr Allan, as there is no legal obligation indeed or finance upon the tree's owner to cut growth back from a neighbour's property. The property owner has the right to remove the offending vegetation (that being any material part of the tree above or below ground that encroaches into a neighbour's property) back to the common boundary and no further unless the tree is within a Conservation Area or is protected by a Tree Preservation Order then an application must be made to the Planning Department. Encroachment or works by persons not authorised beyond the common boundary may constitute trespass and/or criminal damage'.

We have therefore advised the resident accordingly. Therefore, this case is now closed.

Finally, re the Grange: -

The Manager of Hurworth Grange has reported that there are no problems with the trees on the estate at this time. The storm we had recently damaged the building, but did no damage to the trees causing any serious issues/danger.

Cllr Foster added that he has inspected several of the old oak trees in the parish, and that they are sound. However, he has also contacted DBC about the large ash trees which border Neasham Road. DBC has been and cut back several trees, but have not addressed the broken branches and pruning of the ash trees which are situated further back, these require tree work, and are the responsibility of DBC. It was agreed that ward Cllr Walters would contact Phil Haynes to arrange for further work to be carried out. **Action Cllr Walters**

Cllr Oughton reported that there is a tree in Coach Lane which is leaning and partially damaged. Ownership is not known, and it was agreed that the Clerk will investigate. **Action Clerk**

12. Open Spaces - Cllr Charlotte Marie Kay gave the following report: -

Open Spaces and Environment Report September 2023

As a new councillor to the role, I am currently still finding my bearings with regards to the requirements and what comes under the remit.

Grange areas

I have reached out to the Grange for information on the volunteers that are involved in our Open spaces and hope to have contact with these individuals for their input with regards to, support required, any issues, ideas for improvements and long-term planning for the next meeting.

The Orchard – I have witnessed that there are currently 2 trees which have gone over and possibly cutting back required due to some issues with the trees. It would be useful to speak with the volunteers maintaining this area for their input and also involve our tree councillor for his opinion on the care of the trees.

Parish Benches.

I am planning a monthly route to hopefully visit all parish benches as an ongoing inspection.

Benches checked currently seem in good order. Some revarnishing will be required in the spring.

A bench on the Grange Field is getting overgrown, possibly preventing access to it for seating. As the temperature is due to drop this growth will subside however, this will need reviewing to ensure maintained when the growing season begins in the spring.

Bins & Dog Waste

The ones I have seen are in good order. I would say a 'just in time' emptying schedule however, some utilised more than others. Grange Bin by turn stile knocked over on a number of occasions. Worth possibly looking into an alternative solution from DBC. I will monitor this.

Community

Thank you to the many volunteers which are making a difference to our open spaces around the village.

If residents around the village see and issues, please report them so they can be rectified as timely as possible. Also, any ideas for improvements for our open spaces.

17. Matters of Interest

- a. **Correspondence** Chair
 - 1 The council has been offered free trees from DBC Tees project. The council agreed that as we have over 600 trees to tend, we will not request any more at this time.
 - DBC are carrying out a survey on the location of Polling Stations for forthcoming elections. In the past, Hurworth Grange has been suggested, and DBC Electoral team did visit and inspect the facility. They deemed it suitable. The meeting had varying views and it was agreed we will respond with a 'neutral' letter. **Action Clerk.**
 - 3 We have received a letter from All Saints PCC requesting a donation of £250 to help to cover the costs of a Christmas Tree Festival, which will include many of the youth organisations in the parish. Cllr Lennox [proposed a motion to donate £250, Seconded by Cllr Forster. The motion was carried unanimously. **Action Clerk**
- b. New Hurworth Grange lease Chair

The Chairman informed the meeting that the draft new 7-year lease between HPC and Hurworth Grange CIO has been sent to Luke Swinhoe, DBC Head of Law Department, for checking the legal correctness and provide confirmation. The Chair has stressed the need for a termination clause, which is a get-out clause with 3 months notice.

c. Training - Chair

The Chairman stated that only Cllr Lennox had enrolled in the series of recent Councillor training courses, and suggested that we arrange to hold a Good Councillor course, here at Hurworth Grange. A date to be suggested.


